Dear Voter,

Our records indicate that you are eligible to vote under the Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA). You can vote in the upcoming election either with the electronic ballot sent to you by Cache County or by using a federal write-in absentee ballot (FWAB).

UOCAVA ballots are sent: 09/20/2024

Last day to request a ballot: 11/04/2024

Postmark deadline: 11/04/2024

General Election Day: 11/05/2024

Election canvass: 11/19/2024

- Electronic ballots must be received by the Elections Office by 8:00 PM (Mountain Standard Time) on Election Day, Tuesday, November 5, 2024.
- Mailed ballots must be postmarked no later than the day **BEFORE** Election Day, Monday, November 4, 2024, and received up through the Election Canvass.
