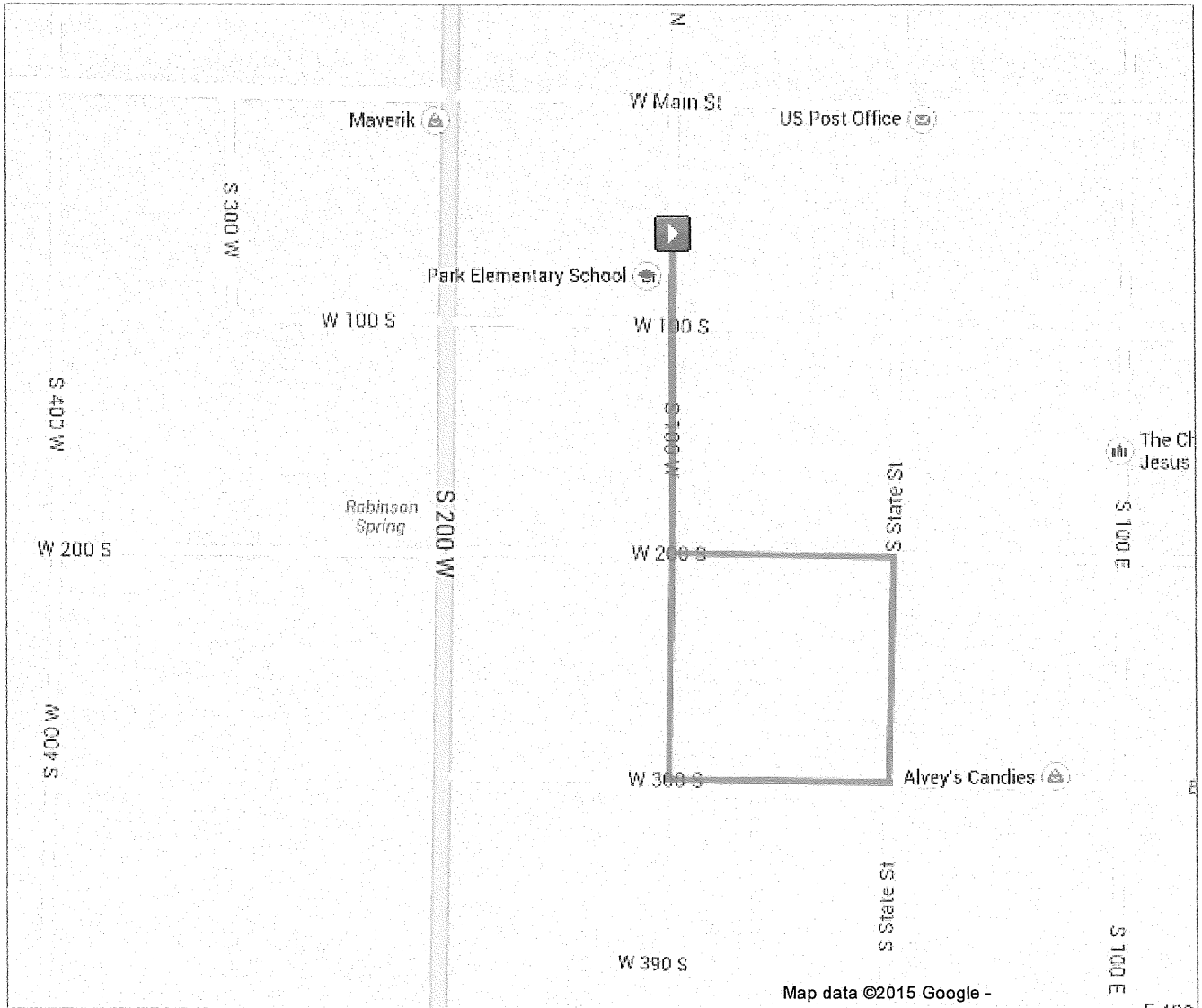

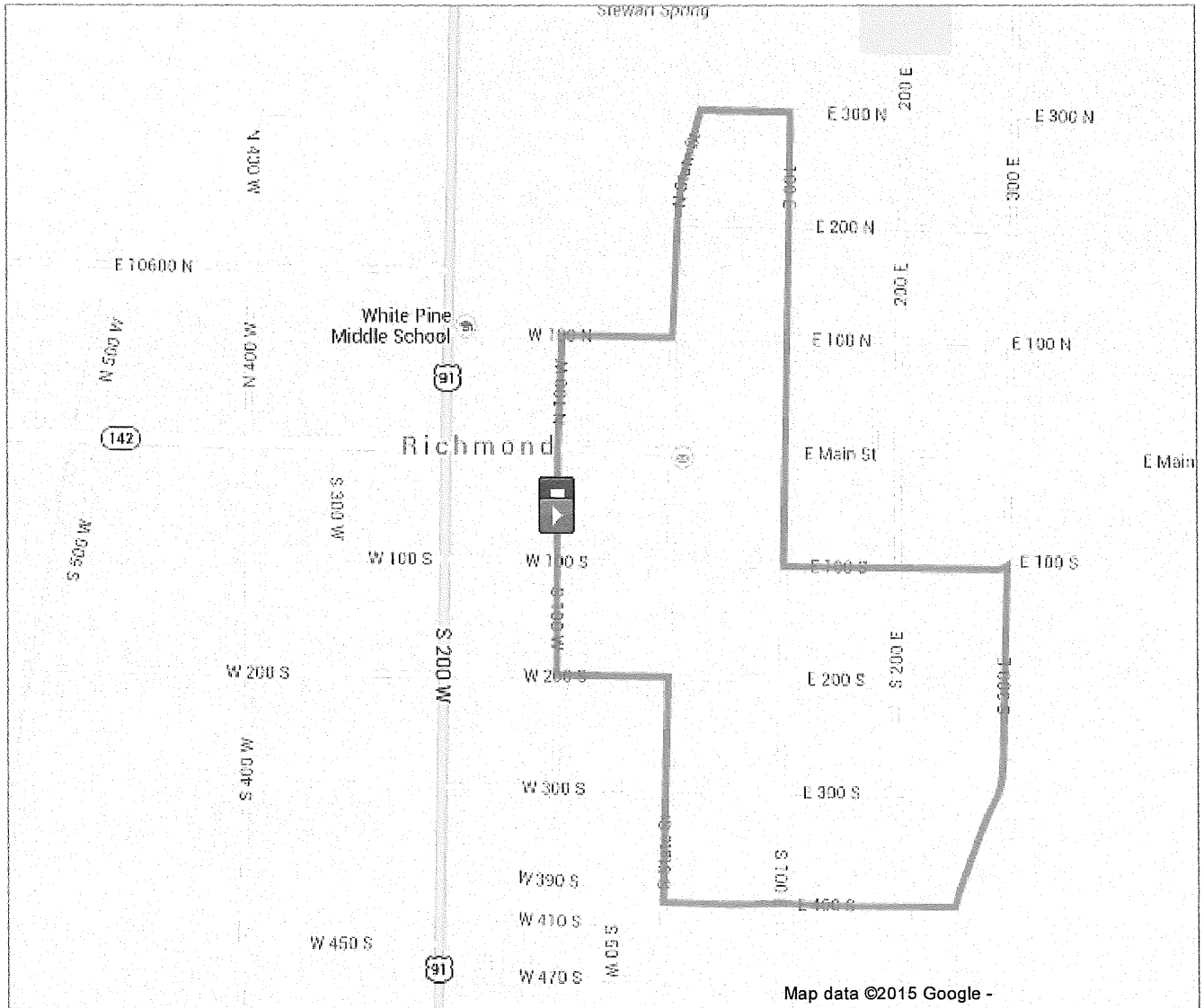
COWABUNGA RACE - 1 MILE

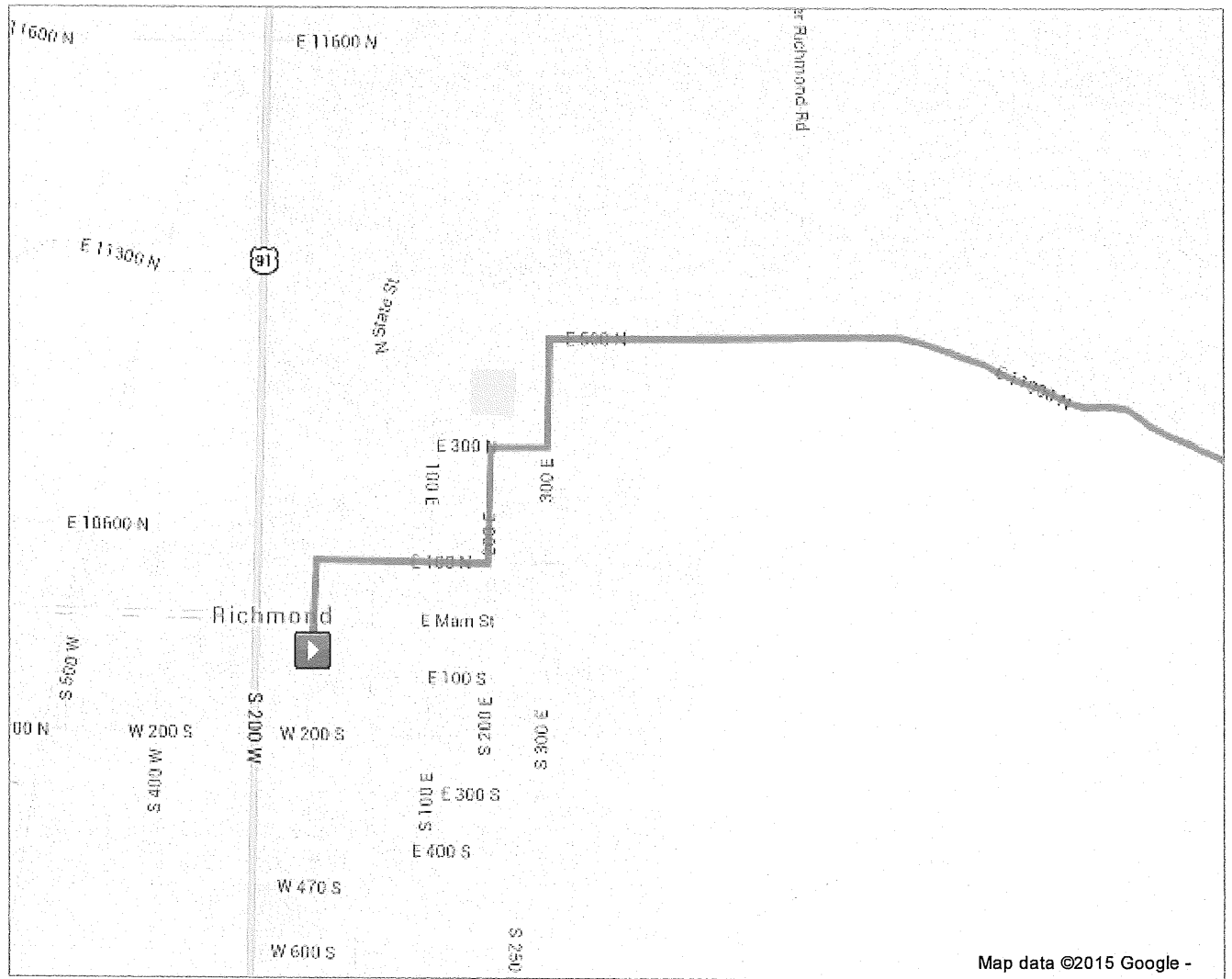
COWABUNGA RACE - 5 KILOMETER
