ANNEXATION BOUNDARY DESCRIPTION

Beginning at the Northeast Corner of Lot 1 of Lafonzo Estates 2010 Amendment, Entry Number 1,023,154, said Point being on the Existing Millville City Corporate Boundary Line and RUNNING THENCE along said Millville Corporate Boundary Line the Following Seven (7) Courses: (1) North 87°37'41" West (North 87°51'01" West by Record) 406.40 Feet Along said Lafonzo Estates; (2) South 02°54'40" West (South 02°41'15" West by Record) 635.40 Feet to the Southwest Corner of said Lafonzo Estates; (3) South 89°19'40" East (South 89°33'00" East by Record) 158.52 Feet Along said Lafonzo Estates; (4) South 02°10'20" West 408.14 Feet (South 01°30' West 405.90 Feet by Record); (5) North 89°19'40" West (West by Record) 271.93 Feet; (6) North 09°30'03" East (North 08°36' East by Record) 422.25 Feet to the South Line of said Lot 9; (7) North 89°08'37" West (West by Record) 651.28 Feet to the Center of the Providence Blacksmith Fork Canal; Thence Along said Canal Center the Following Sixteen (16) Courses: (1) North 08°19'55" East 5.41 Feet; (2) North 07°09'37" West 25.97 Feet; (3) North 00°26'35" East 27.50 Feet; (4) North 16°35'57" East 136.29 Feet; (5) North 30°13'27" East 32.88 Feet; (6) North 21°49'55" East 54.39 Feet; (7) North 21°42'09" East 59.07 Feet; (8) North 33°33'11" East 22.07 Feet; (9) North 23°23'31" East 48.20 Feet; (10) North 12°42'16" East 49.84 Feet; (11) North 08°35'38" East 20.85 Feet; (12) North 18°40'19" East 35.94 Feet; (13) North 23°00'58" East 54.84 Feet; (14) North 15°15'24" East 26.98 Feet; (15) North 09°36'52" East 29.43 Feet; (16) North 13°14'12" East 104.38 Feet to Entry Number 1,168,410, being the North Line of a Private Lane; Thence South 87°29'58" East 941.45 Feet Alona said North Line and said Entry Number to the Intersection with the West Right-of-Way Line of Main Street; Thence South 01°27'16" West 21.25 Feet Along said West Right—of—Way Line to the Intersection with said Existing Millville City Corporate Boundary Line: Thence South 01°27'16" West 35.67 Feet Along said Existing Corporate Boundary Line to the Point of Beginning. 
