BEFORE THE BOARD OF COUNTY COMMISSIONERS

Cache County, State of Utah.

In the matter of the organization of a drainage district to be known as the Cache County Drainage District, No. 1, in Cache County, State of Utah.

P E T I T I O N

To the Honorable Board of County Commissioners
in and for the said Cache County, State
of Utah:

Your petitioners respectfully submit the following:

(1) That your petitioners comprise more than one-half of the owners of title or evidence of title to lands within the area proposed herein to be organized as a drainage district in the name of the Cache County Drainage District, No. 1, in Cache County, State of Utah, and that they own and control more than one-third of the area proposed to be included in the organization, which lands are susceptible of reclamation by drainage, and your petitioners desire to provide for the reclamation of the said lands included within the area as hereinafter bounded and described.

(2) The lands which your petitioners desire to have included within the proposed drainage district are situated in the said county of Cache, State of Utah, and the boundaries of the proposed district are as follows:

Beginning at the northeast corner of Section 10, Tp. 14 No., Range 1 W., Salt Lake Base and Meridian, thence south one mile, thence S. 45 deg. W. 3734 feet, to the center of Section 15, thence south one mile to the center of Section 22, thence S. 45 deg. E. 3734 feet to the southeast corner of Section 22, thence south one-

half mile to the east quarter corner of Section 27, thence west one and one-fourth miles, thence N. 45 deg. W. 3734 feet to the southwest corner of the southeast quarter of the southwest quarter of Section 21, thence north three and one-half miles to the southwest corner of the southeast quarter of the northwest quarter of Section 4, thence N. 18 deg. 25 min. E. 4177 feet, thence east one-half mile, thence south three-quarters mile, to the north quarter corner of Section 10, thence east one-half mile to the point of beginning, inclosing an area of approximately 3900 acres; and a more particular description of the lands proposed to be included within the boundaries of the proposed drainage district as follows;

The southwest quarter and the south half of the northwest quarter of Section 3, Tp. 14 No., R. 1 W., Salt Lake Base and Meridian; the southeast quarter, the east half of the southwest quarter, the southeast 7 acres of the northwest quarter and the southeast 53 acres of the northeast quarter of Section 4; the east half and the east half of the west half of Section 9; all of Section 10; the west half and northwest half of the northeast quarter of Section 15; the east half and the east half of the west half of Section 16; the east half and the east half of the west half of Section 21; the west half and the southwest half of the southeast quarter of Section 22; the north half of Section 27; the northeast 140 acres of the northeast quarter and the northeast 20 acres of the northwest quarter of Section 28.

(3) The starting points, routes and termini and general description of the proposed drainage system are as follows:

A main drain beginning at the culvert under the O. S. L. Railroad just north of Trenton, Utah and following the Ransom Slough, northwest and north through Sections 27, 28, 21, 16, 9 and 4 to a

point near the center of Section 4, Tp. 14 N., R. 1 W. Salt Lake Base and Meridian.

The necessary laterals and interior drainage.

The laterals and interior drainage lines are to be covered clay tile drains. As much as possible of the main drain is to be covered clay tile drain but wherever the grade is insufficient or the required capacity too great, the drain is to be an open canal.

(4) Your petitioners herewith submit a true copy of the equalized county assessment roll for the year 1919 being the roll next preceeding the presentation of this petition for the organization of the said drainage district, as shown by the records and assessment roll in the office of the county assessor of Cache County, State of Utah, as evidence of the ownership and title to said described lands, which said copy of said assessment roll is attached hereto, marked "Exhibit A" and made a part of this petition.

(5) Your petitioners herewith append an affidavit giving a list of non-residents who own land within the boundaries of the proposed district together with their places of residence when known, and where not known, stating the fact and that upon diligent inquiry they could not be ascertained, which said affidavit is attached hereto, marked "Exhibit B" and made a part of this petition.

(6) Your petitioners herewith present an indemnity bond in the sum of \$2,000 which is equivalent to 2 percent of the estimated cost of the proposed drainage work, conditioned for the payment of any organization, preliminary and other lawful costs, in the event that this petition is denied or that, upon investigation, it is found that the cost of improvement will be in excess of the benefits to be derived, thereby necessitating the dismissal of the proceedings, which said indemnity bond is attached hereto, marked "Exhibit C" and made a

part of this petition.

Wherefore, your petitioners respectfully pray as follows:

(1) That pursuant to the provisions of Chapter 95 of the Session Laws of Utah, 1913, and amendments thereto, the land above described and bounded be organized into a drainage district to be known as Cache County Drainage District, No. 1, in the County of Cache, State of Utah, that said lands may be drained and reclaimed and protected.

(2) That your honorable body fix a time and place for a hearing on this petition, and that due and legal notice of the time and place for a hearing upon said petition and the purpose for which the petition will be heard, be given as required by law, to all parties interested.

Your petitioners further pray that the said petition be granted; that the proposed drainage district be organized as a body corporate and that three drainage supervisors be appointed as provided by statute.

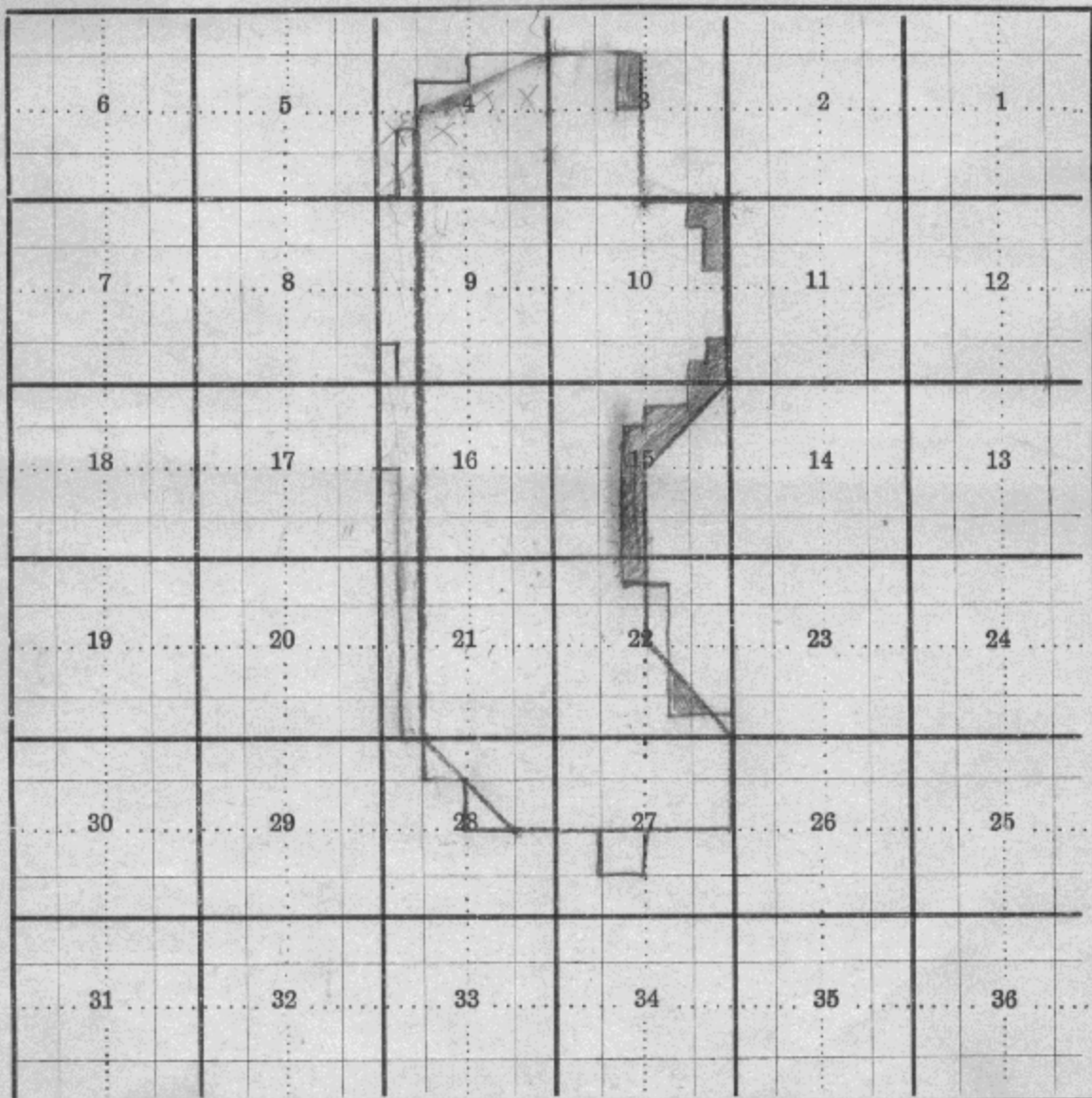

A Committee composed of R. E. Butler, H. K. Hoff and Melvin H. Buttars presented a written petition on behalf of said R. E. Butler et al., by more than a majority of the land owners owning more than a majority of the land within the proposed Drainage District to be known as the Cache County Drainage District #1. On motion of Commissioner Murray seconded by Commissioner Hyer it was ordered that the petition as presented by the Committee be accepted and filed by the Clerk. Thereupon Commissioner Murray moved the adoption of the following Resolution:

R E S O L U T I O N

Whereas, R. E. Butler et al., have this day filed with the County Commissioners a Petition in due form by a majority of the land owning a majority of the lands in the proposed Irrigation District and praying for the creation of a Drainage District to be known as Cache County Drainage District #1 which petition contains a general description of the work proposed and a particular description of the proposed boundaries of the District together with a list of the land owners and the amount of land owned by each and their place of residence together with a Undertaking in the sum of \$2000.00 being 2% of the estimated cost of the proposed improvements in the said Drainage District in the manner and form required by law.

Now, therefore in consideration of the premises it is hereby ordered that Thursday the 19th day of May¹⁹²¹ at 10 o'clock A.
