**AMENDMENT NO. 1
TO THE INTERLOCAL AGREEMENT
LOGAN-CACHE AIRPORT AUTHORITY**

This AMENDMENT NO. 1 (“Amendment”), is made this ____ day of May 2025, to the INTERLOCAL AGREEMENT LOGAN-CACHE AIRPORT AUTHORITY (“Agreement”) between Cache County (“County”) and Logan City (“City”) executed on December 1, 1992.

BACKGROUND

Effective December 1, 1992, the Parties executed the Agreement with the intent to own, fund, manage and operate the Logan-Cache Airport (“Airport”) facilities through the Logan-Cache Airport Authority.

The purpose of this Amendment is to: (i) increase the number of members of the Board from seven (7) to eight (8) members; and (ii) allow the Airport Board to authorize one (1) appointee from Utah State University as a member of the Board.

AMENDMENT

Accordingly, the Parties agree to amend the Agreement as follows:

1. Subsection 8(b) in the Agreement entitled “Composition” is hereby revoked and replaced with the following:
 - (1) The Board shall consist of eight (8) members.
 - (2) The members of the Board shall include the following:
 - a. Cache County Executive or his/her designee.
 - b. Logan City Mayor or his/her designee.
 - c. Two members at large appointed by the City.
 - d. Two members at large appointed by the County.
 - e. One member at large appointed by the other seven members upon a 2/3 vote approving the appointment. If 2/3 of the members cannot agree upon an appointment, the County may appoint the member.
 - f. One member representing Utah State University appointed by the Airport Authority Board.
 - g. The Directors of Economic Development of the City and the County May serve as ex-officio non-voting members of the Board.

(3) It is intended that the members at large shall have an interest in and knowledge of aviation and the airport, and/or in economic development.

2. Integrated Agreement: Apart from the Amendment described above, the Agreement remains unchanged and in full effect and shall be interpreted as a part thereof of a single integrated agreement.
