He also reported that Logan City is reducing the size of the Kunzler Property Conservation Easement, thereby reducing the amount needed from RAPZ to \$82,620. The additional funds, which had been allocated, will be returned to the RAPZ fund.

The primary revision would change the consent requirement for a winery so that consent only has to be given once, rather than annually when a business reapplies for a license. Luthy said that he would follow up on questions from the Council regarding whether a winery could sell other alcohol products like a liquor store. Luthy said that the ordinance also needs clarification regarding advertising restrictions, and could include expanded Council oversight including national background checks and notice of ownership changes. Council members and Luthy discussed concerns about cultural changes to Cache Valley, and how many acres of crops would be required in a land use ordinance.

Action: Motion made by Karl Ward to table the discussion until there are land use codes and ordinances in place. Motion dies due to lack of second. Ordinance 2021-05 will be placed on the next council agenda. **Motion dies.**

Andersen said the increase in the workload over the last 40 years while maintaining the current full-time staffing plan. As a result, services provided have declined. Requesting three full-time positions. The Finance Department indicates that money is available for these positions. Gina Worthen states that a decision cannot be made without a public hearing. Due to that requirement, Devron Andersen withdraws his request for a vote on the matter in this meeting.
- b. **Discussion:** Trail Concept for the SR165 corridor between Paradise and Avon Jason Summers, Prime International, LLC and Carly Lansche, Regional Trails Coordinator: Phases of trail to reach Porcupine Reservoir. Not on the master plan, not a priority for the county. Positive support received through an online petition. Concerns with a paved trail and a parking lot would be an increase in traffic, garbage, and littering. County road vs state road concerns and parameters. SR165 corridor is owned by the Utah Department of Transportation. (1:46.10)

Explanation for RAPZ Project Funding Continuation Logan City Projects

Project: West Willow Angels Landing Playground Surface Replacement

\$59,000 Awarded in 2017

\$44,016.13 Remaining

Surface replacement has been purchased and City crews will install the surface materials (panels) at the completion of the playground equipment installation. Work is continuing as weather permits. The surface replacement requires warmer temperatures for adhesive to bond the surface panels to the concrete foundation. Completion is anticipated by September 30, 2021.

Progress of the work has been hampered in part by a backlog of maintenance projects, a competitive labor market for summer help that limited our progression, effects of COVID-19 amongst staff, and delays in materials needed from suppliers impacted by the pandemic.

Continuation Request: Logan City is requesting an extension of seven (7) months to complete the project.

Project: Canyon Road 500 East to 600 East Trail Construction

\$75,000 Awarded in 2017

\$14,212.77 Remaining (\$9,376.60 encumbered)

Work is expected to be complete by May 31. Initial scope included a subsurface Geotech survey of the hillside in 2018 where the trail was proposed at 600 East Canyon Road and continue west to 500 East Canyon Road. The results of the survey indicated that significant retaining wall construction would be needed to support the trail on the northside of Canyon Road. Overarching purpose of trail connectivity is to reduce at-grade street crosses for trail users, however it was determined that existing sidewalk on the south side of Canyon Road would be used and improvements made at the intersection of 400 East 100 North Canyon Road to improve the pedestrian trail crossing at Canyon Road. This involves sidewalk reconstruction that connects to the Temple Trail from Canyon Road to the Boulevard and to 500 East and 600 East. Safety fencing for the trail has been installed. Pedestrian crossing beacons (\$9,376.60) have been ordered and the balance of RAPZ (\$4,836.17) will be matched to City funds for the remainder of the construction contract.

Continuation Request: Logan City is requesting an extension of three (3) months to complete the project.

Explanation to Reduce RAPZ Funding Kunzler Property Conservation Easement Project

Project: Kunzler Property Conservation Easement

\$150,000 Awarded

\$82,620 New adjusted amount from Utah Quality Growth Commission Hearing

The Utah Quality Growth Commission approved a request by the City of Logan to reduce the original amount of easement and subsequent grant funding as a result of reconsideration by the owner's developer for the property from 73 acres to 47 acres. The reduction in acreage also reduces the matching amount from RAPZ. This change in funding from RAPZ for the City's original application of \$150,000 is now reduced to \$82,620 and the same for the matching RAPZ funds from the County's application, again from \$150,000 to \$82,620. The easement acquisition will still allow the Logan River Trail to be expanded onto the Kunzler property from Trapper Park. The additional area will provide up to an additional 1.6 miles of public trail.

Project Request: Logan City is requesting to reduce amount of RAPZ funds to \$82,620 for City application and County application.

CACHE COUNTY RESOLUTION 2020 - 25

RESOLUTION DECLARING COUNTY INTEREST IN REAL PROPERTY LOCATED ON WOLF PACK WAY, DESCRIBED AS PARCEL NUMBER 04-058-0051 AS SURPLUS PROPERTY

WHEREAS, Cache County intends to sell the County interest in real property described in Exhibit "A"; and

WHEREAS, Utah Code Ann. Section 17-50-312 provides that the county legislative body shall provide by ordinance, resolution, rule or regulation for the manner in which property shall be acquired, managed, and disposed of; and

WHEREAS, prior to the sale of said Property, Cache County Ordinance Section 3.40.010 requires the Cache County Council to declare said property as "Surplus Property"; and

WHEREAS Cache County Ordinances Sections 3.40.020 and 3.40.040 establish the procedures and protocols that must be followed prior to declaring the property as "Surplus Property" before it can be conveyed to a purchaser; and

WHEREAS the Cache County Council must hold a public hearing pursuant to Cache County Ordinance Section 3.40.040(B) before, by motion and vote, the Cache County Council can declare the Property as "Surplus Property" so that it can be conveyed to a purchaser; now

THEREFORE, the Cache County Council finds as follows:

- 1. That it is in the public interest that the subject real property be disposed of as surplus property. In determining whether the property shall be declared surplus, the County Council has taken into consideration:
 - a. Whether the county has, or anticipates that it will have, no practical, economical, efficient or appropriate use for the property currently or in the reasonably foreseeable future.
 - b. Whether the purpose served by the property can be better accomplished by other alternatives or property.
 - c. Whether the purpose served by the property or its use either no longer exists or has significantly changed because of the needs and demands of the county or as may be determined by a change of policy evidenced by an ordinance or resolution of the county council.
 - d. Whether the property is so damaged, depreciated or worn that it is inoperable or limited in operation without repairs and the cost of such repairs is unreasonable, excessive or impractical.
 - e. Whether the purposes and interests of the county would be better served by the declaration of the property as surplus and the disposition of that property.

THEREFORE, the Cache County Council, after holding a public hearing, resolves that the Property, better described in "Exhibit A" shall be declared surplus, and that such surplus property may be disposed of by the County Executive subject to the provisions of Cache County Code Chapter 3.40. This resolution takes effect immediately upon adoption.
