# 5. Report of the County Executive

- a. County Executive David Zook Reported on his meetings with UDOT about upcoming road projects within the county. He also reported on most recent CMPO meeting about other road projects, the grand opening of the new veteran's center, meeting with the Red Cross and his most recent meeting with the Budget Committee. He also met with federal leaders in Washington D.C about the needs of the county.

### 6. Items of Special Interest

a. Flood Plain Mapping

**Discussion:** Public Works Director Matt Phillips presented on the history of flood mapping and where the county currently stands in regards to flood mapping. He also reported on the upcoming meeting on August 9<sup>th</sup>, in which state officials will present the new flood maps.

# 7. Department or Committee Reports

a. Children's Justice Center

**Discussion:** Terryl Warner presented on the new Children's Justice Center and what new services the center now can provide and the new artwork that is presented there.

b. Clerk/Auditor's Office

**Discussion:** County Clerk/Auditor Jess Bradfield presented on the new improvements being made in his office, which includes a mass digitizing of all records for greater public accessibility. Bradfield also explained that the county is assisting municipal elections within Cache County. Bradfield presented on the completions of two performance audits. Bradfield explained the audits of the County Recorder's Office and Executive's Office were a "general overview" and looked at compliance with state code. Two attorneys went in and asked if the offices were following each item required by state law. The audit reports highlight

what changes were recommended, and do not include the spreadsheet checklist of statute compliance. Council members questioned the finding which recommended moving the office of Surveyor from the office of County Executive. Currently the Surveyor work is contracted out. Auditor Bradfield said the recommendation was based on the potential for waste, fraud and abuse. Council members asked if any waste, fraud or abuse had been found. Bradfield said no. Council member Gunnell commented that waste, fraud and abuse isn't limited to contractors, but can also be committed by elected officials and that separating out the office would not necessarily prevent waste, fraud and abuse. Council members asked if any cost comparisons had been done between in-house and contracting the survey work. Bradfield said no comparisons had been done.

The Council also questioned why a recommendation was included in the audit to change the name of the County Executive to County Mayor. Bradfield explained that it was his office's opinion and based on a soft poll, not a scientific poll, that no one knew what a County Executive was.

Council members Karl Ward and Gina H. Worthen emphasized that the County Executive is different from a Mayor. The Executive does not have the same functions and oversight as a mayor.

Council member Erickson expressed concern that it appeared the results of the audit were predetermined. Auditor Bradfield assured Erickson that the two attorneys conducting the audit went in open minded.

The Council also expressed concern that audits are black and white, and not opinion-based. Council member Ward also said if something is broken, then it needs to be pointed out specifically why and what the consequences have been when making recommendations for a fix.

# b. Request for Chief Deputy Recorder Position **DENIED**

**Discussion:** County Recorder Devron Andersen presented on his need of a highly qualified Chief Deputy to assist with a 66% increase in workload. Andersen stated that the county has advertised the position three times and only 1 highly qualified candidate applied. That individual declined the job offer, citing a low wage for an experienced employee. Andersen asked for approval to raise the starting pay above the currently allowable .95 compensation ratio. Councilmembers Erickson, Gunnell and Borup expressed concern about raising the pay and the possibility of creating a precedent. They desired the office to contract the work instead of hiring a long-term Chief Deputy at an increased wage.

Action: Motion made by Karl Ward to approve the request to waive the normal hiring procedures and raise the offer by \$14,000 and to allow 40 PT front loading under the condition. Also contract immediate qualified help, not overlooking the former county recorder, and get help from GIS; Seconded Barbara Tidwell

**Action:** Motion made by David Erickson to amend the main motion and strike "waive the normal hiring procedures and raise the offer by \$14,000 and to allow 40 PT front loading," leaving only "contract immediately or get temporary qualified help, not overlooking the former county recorder, and get help from GIS," seconded by Paul Borup.
