CACHE COUNTY ORDINANCE NO. 2022 - 26

AN ORDINANCE AMENDING SECTION 9.04.10 OF THE CACHE COUNTY CODE TO CLARIFY PROVISION AND CONFORM WITH STATE CODE REGARDING TRAFFIC CONTROL DEVICES

- (A) WHEREAS, the Cache County Code references and incorporates various provisions the Utah Code; and
- (B) WHEREAS, Section 10 of Chapter 4 of Title 9 of the Cache County Code as currently constituted prescribes a sentence greater than that allowed by a Class B Misdemeanor under Utah Code; and
- (C) WHEREAS, Chapter 4 of Title 9 of the Cache County Code is ambiguous in its reading as it concerns first and second offenses; and
- (D) WHEREAS, the Cache County Council has an interest in maintaining the clarity and applicability of the references to the Utah Code found in the Cache County Code;
 - NOW, THEREFORE, the County Legislative Body of Cache County ordains as follows:

SECTION 1:

Section 9.04.10 of the Cache County Code is amended to read in full as follows:

9.04.010: TAKING, POSSESSING, REMOVING OR DAMAGING TRAFFIC CONTROL DEVICES:

- A. It is unlawful for any person to willfully take, possess, remove, transport, store, relocate, destroy, take down, deface, alter, mark, write upon, cover, injure, or otherwise tamper with any traffic control device or attempt to do so in whole or partially, whether such action is permanent or temporary, without specific written authority to do so.
- B. A "traffic control device" means and includes, but is not limited to, any sign, signal, road marker, barricade, flare, warning light, reflector, railroad sign or signal, shield, insignia, milepost, street sign, or other similar device which is placed upon any highway or street by the County or by any governmental agency or their designee.
- C. The unauthorized possession of any county traffic control device or sign shall be prima facie evidence of a violation of this section.
- D. Violations of this section shall be punishable in the manner provided for class B misdemeanors.
- E. Any firearms, tools, instruments or motor vehicles used in the commission of any violation or offense under this section in this defense shall be subject to confiscation by any law enforcement agency having jurisdiction over the offense.



SECTION 2:

This ordinance takes effect 15 days following its passage and approval by the County Council.

9.04.010: TAKING, POSSESSING, REMOVING OR DAMAGING TRAFFIC CONTROL DEVICES:

- A. It is unlawful for any person to wilfully willfully take, possess, remove, transport, store, relocate, destroy, take down, deface, alter, mark, write upon, cover, injure, or otherwise tamper with any traffic control device or attempt to do so in whole or partially, whether such action is permanent or temporary, without specific written authority to do so.
- B. A "traffic control device" means and includes, but is not limited to, any sign, signal, road marker, barricade, flare, warning light, reflector, railroad sign or signal, shield, insignia, milepost, street sign, or other similar device which is placed upon any highway or street by the eCounty or by any governmental agency or their designee.
- C. The unauthorized possession of any county traffic control device or sign shall be prima facie evidence of a violation of this section.
- D. Any violation of this section shall be deemed a class B misdemeanor. Violations of this section shall be punishable in the manner provided for class B misdemeanors.
- E. Any firearms, tools, instruments or motor vehicles used in the commission of any violation or offense under this section in this defense shall be subject to confiscation by any law enforcement agency having jurisdiction over the offense.
- F. Any person who is convicted of a second or subsequent offense under this section shall be fined in an amount not less than one hundred dollars (\$100.00) nor more than one thousand dollars (\$1,000.00), sentenced to jail for a period not exceeding one year, or a combination of such fine and jail sentence. First violations of this section shall be punishable in the manner provided for class B misdemeanors.

A RESOLUTION TO (1) AUTHORIZE PLACEMENT ON THE NOVEMBER 8, 2022 GENERAL ELECTION BALLOT OF A PROPOSITION FOR THE ISSUANCE OF GENERAL OBLIGATION BONDS NOT TO EXCEED \$20,000,000 FOR PAYING ALL OR A PORTION OF THE COSTS OF PURCHASING LAND, CONSERVATION EASEMENTS, AND OTHER INTERESTS IN LAND FROM WILLING LANDOWNERS IN ORDER TO PROTECT SCENIC VISTAS, PRESERVE OPEN LANDS NEAR VALLEY GATEWAYS, ADD TRAILS AND TRAIL CONNECTIVITY, AND MAINTAIN AGRICULTURE, WATERWAYS, AND WILDLIFE HABITAT; (2) PROVIDE FOR THE PUBLICATION OF A NOTICE OF PUBLIC HEARING; (3) APPROVE THE FORM AND DIRECT THE PUBLICATION OF A NOTICE OF ELECTION AND THE BALLOT PROPOSITION; AND (4) RELATED MATTERS

WHEREAS, the results of a scientific survey of residents of Cache County conducted during May and June of 2022 showed that, on a scale of 1 to 10, 74.6% of respondents rated the importance of preserving agricultural open space in the south gateway of Cache County at an 8, 9, or 10, with the median score being 9 and the average score being 8.39; and

WHEREAS, the results of the same survey showed that 74% of respondents rated the importance of preserving agricultural open space in the north gateway of Cache County at an 8, 9, or 10, with the median score being 9 and the average score being 8.37; and

WHEREAS, the results of the same survey showed that 71.3% of respondents rated the importance of preserving agricultural open space in non-gateway areas of Cache County at an 8, 9, or 10, with the median score being 9 and the average score being 8.25; and

WHEREAS, the results of the same survey showed that 87% of respondents rated the importance of preserving scenic lands and vistas in Cache County at an 8, 9, or 10, with the median score being 10 and the average score being 9.02; and

WHEREAS, the results of the same survey showed that 74% of respondents rated the importance of adding trails, trail connections, and trail facilities in Cache County at an 8, 9, or 10, with the median score being 9 and the average score being 8.46; and

WHEREAS, the results of the same survey showed that 89% of respondents rated the importance of open space around waterways in Cache County at an 8, 9, or 10, with the median score being 10 and the average score being 9.02; and

WHEREAS, the results of the same survey showed that 84.5% of respondents rated the importance of open space that provides wildlife habitat in Cache County at an 8, 9, or 10, with the median score being 10 and the average score being 8.96; and



WHEREAS, the results of the same survey showed that 89% of respondents said that they are willing to pay \$20 annually in property tax to fund an open space bond; 68% of respondents said that they are willing to pay \$30 annually in property tax to fund an open space bond; and 56% of respondents said they are willing to pay \$40 annually in property tax to fund an open space bond; and

WHEREAS, the County Council (the "Council") of Cache County, Utah (the "County"), desires to promote the preservation of open lands in Cache County by purchasing land, conservation easements, and other interests in real property from willing landowners for the purposes of protecting scenic vistas, preserving open lands near valley gateways, adding trails and trail connectivity, and maintaining agriculture, waterways, and wildlife habitat (the "Project"); and

WHEREAS, the County does not have money on hand to pay all of the costs of the Project and the Council has determined to ask the qualified voters of the County for authorization to finance the cost of the Project through the issuance of up to \$20,000,000 of the County's General Obligation Bonds (the "Bonds"); and

WHEREAS, the Council desires to submit a proposition concerning the issuance of the Bonds to the vote of the qualified electors of the County pursuant to the provisions of the Local Government Bonding Act, Utah Code §§ 11-14-101 through -501, as amended, and applicable provisions of the Utah Election Code, Utah Code §§ 20A-1-101 through 20A-20-303, as amended (collectively, the "Act");

NOW, THEREFORE, BE IT RESOLVED by the Council as follows:

Section 1. <u>Definition of Terms</u>. The terms defined or described in the recitals hereto shall have the same meaning when used in the body of this Resolution.

Section 2. <u>Election Call</u>. On November 8, 2022, there shall be held in the County a special bond election (the "Bond Election"), between the hours of 7:00 a.m. and 8:00 p.m., at which there shall be submitted to the qualified electors of the County the proposition appearing in the ballot proposition portion of the Notice of Election as substantially set forth in Section 6 hereof (as it may be appropriately and legally updated, modified, corrected, or completed).

Section 3. <u>Voting Places and Election Judges</u>. For purposes of the Bond Election, the voting methods, voting precincts, voting places, and election judges, alternate judges, and poll workers to serve at the voting places shall be the same as those established for the general election held that day.



Section 4. <u>Authorization and Reimbursement of Expenses</u>. The Bond Election shall be conducted and the registration therefor shall be governed in conformity with the laws of the State of Utah, including particularly the Act, and the officials of the County, as applicable, shall be and hereby are authorized and directed to perform and do all things necessary for the proper calling and conduct of the Bond Election and the canvass of the results thereof.

In the event the proposition for the Bonds is approved at the Bond Election, the County reasonably expects to reimburse itself from proceeds of the Bonds for capital expenditures advanced for the acquisitions herein described in a principal amount of not more than \$20,000,000.

Section 5. <u>Public Hearing</u>. The Council will hold a public hearing on September 27, 2022, to receive input from the public with respect to (a) the issuance of the Bonds and (b) the potential economic impact that the improvements, facilities or properties for which the Bonds will pay part of all of the cost will have on the private sector, which hearing date shall not be less than 14 days after notice of the public hearing is first posted and shall not be sooner than 30 days or later than 5 business days before the first posting of the Notice of Election as described in this Resolution, such notice to be posted on the Utah Public Notice Website created under Utah Code section 63A-16-601. The "Notice of Public Hearing" shall be in substantially the following form:

NOTICE IS HEREBY GIVEN pursuant to the provisions of the Local Government Bonding Act, Title 11, Chapter 14, Utah Code Annotated 1953, as amended, that on July 26, 2022, the County Council (the "Council") of Cache County, Utah (the "County"), adopted a resolution (the "Resolution") in which it authorized the calling of an election (the "Election") concerning a proposition for the issuance of the County's General Obligation Bonds (the "Bonds") and called a public hearing to receive input from the public with respect to (a) the issuance of the Bonds, and (b) any potential economic impact that the improvements, facilities, or properties financed in whole or in part with the proceeds of the Bonds (see below) may have on the private sector.

Section 7. Mailing of Voter Information Pamphlet. The Council hereby directs the County Clerk of the County (the "County Clerk") to mail at least 15 but not more than 45 days before the scheduled Bond Election, a voter information pamphlet or a notice printed on a postage prepaid, preaddressed return form that a person may use to request delivery of a voter information pamphlet by mail, to each household with a registered voter who is eligible to vote on the Bonds. Said voter information pamphlet shall include, in the following order: (a) the date of the Bond Election, (b) the hours during which the polls will be open, (c) the address of the Statewide Electronic Voter Information Website and, if available, the address of the County Clerk's website, with a statement indicating that the election officer will post on the website the location of each polling place for each voting precinct, each early voting polling place, and each election day voting center, including any changes to the location of a polling place and the location of an additional polling place; (d) a phone number that a voter may call to obtain information regarding the location of a polling place; (e) the title and text of the ballot proposition, and (f) an explanation of the property tax impact, if any, of the issuance of the Bonds which may be based upon information available to the County Clerk, including (i) expected debt service on the Bonds to be issued, (ii) a description of the purpose, remaining principal balance, and maturity date on any outstanding general obligation bonds of the County, (iii) funds other than property taxes available to pay debt service on general obligation bonds, (iv) timing of expenditure of Bond proceeds, (v) property values and (vi) any additional information the Council determines may be useful to explain the property tax impact of issuance of the Bonds.

Section 8. Compliance with the Transparency of Ballot Propositions Act. The County shall comply with the requirements of the Transparency of Ballot Propositions Act, Utah Code §§ 59-1-1601 through -1605, as amended, and shall post the arguments and rebuttal arguments as required by that act on the Statewide Electronic Voter Information Website as described in Utah Code section 20A-7-801, as amended, for 30 consecutive days before the Bond Election. The County shall further post all arguments and rebuttal arguments in a prominent place on the County's website for 30 consecutive days before the Bond Election. If the County has a newsletter published between finalization of the arguments and rebuttal arguments and the date of the Bond Election, it shall further post arguments and rebuttal arguments in such newsletter. When posting the argument and rebuttal argument, the County Clerk shall ensure that: (a) a rebuttal argument is posted in the same manner as a direct argument; (b) each rebuttal argument follows immediately after the direct argument that it seeks to rebut; and (c) information regarding the public meeting (described in the next sentence), follows immediately after the posted arguments, including the date, time, and place of the public meeting. The County shall conduct a public meeting on September 27, 2022, a date which is no more than 45, but at least 4, days before the Bond Election, beginning at the hour of 6:00 p.m. at 199 North Main Street, Logan, Utah. The purpose of the meeting is to hear arguments for and against the issuance of the Bonds. Information regarding this public meeting shall follow immediately after the posted arguments set forth on the Statewide Electronic Voter Information Website and the County's website described herein.



Within three days following the public meeting, the County will post a digital audio recording of the meeting on its website and make it available at the primary office of the County.

Section 9. <u>Election Supplies and Ballots</u>. The ballots to be used at the Bond Election shall comply in all respects with the requirements of the Act at the time of the Bond Election, and the proposition and election instructions with respect to the Bond Election shall be in substantially the form contained in the Election Notice set forth in Section 6 hereof.

Section 10. <u>Appointment of Election Officer</u>. Pursuant to Utah Code sections 20A-1-102 and 20A-5-400.5, the County Clerk will act as elections officer (the "Election Officer"). Other officials of the County are hereby directed and authorized to coordinate with the Election Officer as required for the Bond Election. The Election Officer is authorized and directed to give appropriate notices as required by the Act.

Section 11. <u>Canvass</u>. The ballots shall be counted and the results delivered to the County in accordance with Title 20A, Chapter 4, Part 1 and Part 2, of the Utah Code. The Council shall meet as a Board of Canvassers no sooner than 7 nor later than 14 days after the date of said election, such meeting being currently set for November 22, 2022, at 5:00 p.m., at the regular meeting place of the Council in Logan, Utah, and if the majority of the votes cast at the Bond Election are in favor of the propositions submitted, then the County Clerk shall cause an entry of that fact to be made upon its minutes. Thereupon the Council shall be authorized and directed to issue such Bonds.

Section 12. <u>Severability</u>. It is hereby declared that all parts of this resolution are severable, and if any section, clause, or provision of this resolution shall, for any reason, be held to be invalid or unenforceable, the invalidity or unenforceability of any such section, clause, or provision shall not affect the remaining sections, clauses, or provisions of this resolution.

Section 13. <u>Conflict</u>. All resolutions, orders, and regulations or parts thereof heretofore adopted or passed which are in conflict herewith are, to the extent of such conflict, hereby repealed. This repealer shall not be construed so as to revive any resolution, order, regulation, or part thereof heretofore repealed.

Section 14. <u>Captions</u>. The headings herein are for convenience of reference only and in no way define, limit, or describe the scope or intent of any provisions or sections of this resolution.



Section 15. <u>Recording of Resolution; Effective Date; Notice to Lieutenant Governor and Election Officer</u>. Immediately after its adoption, this Resolution shall be signed by the Chair and the County Clerk, shall be recorded in a book for that purpose, and shall take immediate effect. The County Clerk shall immediately furnish a certified copy of this Resolution to the Lieutenant Governor and the Cache County Clerk in accordance with Utah Code section 11-14-201 by no later than July 27, 2022, a date at least 75 days before the Bond Election.

Section 16. <u>Further Authority</u>. The Council hereby authorizes the County Clerk to make non-substantive changes to any notice or the ballot proposition described herein to complete the same, cure any defect therein, or to make any other changes to such notice or ballot proposition as may be required by the laws of the State of Utah.
