#### THE CACHE COUNTY COUNCIL MEETING MINUTES

February 28, 1995

The Cache County Council met in regular session on the 28th day of February, 1995 in the County Council Chambers located at 120 North 100 West, Logan, Utah 84321.

#### ATTENDANCE

Council members present: Chairman Sarah Ann Skanchy, Council members Guy Ray Pulsipher, H. Craig Petersen, Jerry L. Allen, Darrel L. Gibbons. Vice Chairman C. Larry Anhder arrived late.

Others present: Cache County Executive M. Lynn Lemon; Cache County Clerk Stephen M. Erickson; Cache County Attorney Scott Wyatt; Cache County Auditor Tamra Stones; Cache County Treasurer Karen A. Jeppesen; Cache County Planning & Zoning Administrator Lorene Greenhalgh; Scout Troop 93 from Young Ward with Assistant Scout Master Darin Matthews; Cache County Water Coordinator Thad Erickson; Representatives from the local news media and other interested citizens.

#### CALL TO ORDER

Council Chairman Sarah Ann Skanchy called the meeting to order at 5:00 p.m. and welcomed all who were in attendance. Those in the audience were asked to stand and introduce themselves.

#### INVOCATION

The invocation was given by Councilman Layne M. Beck.

#### AGENDA & MINUTES

The agenda for the meeting was adjusted and approved.

The minutes of the Council meeting held on February 14th, 1995 and sent to all members of the Council were corrected and approved.

Councilman Beck told the Council that he was absent from the last meeting because of bad weather. He had transportation problems due to a snow storm in SLC.

#### REPORT OF THE COUNTY EXECUTIVE

The County Executive M. Lynn Lemon reported on the following items:

1. Appointments:

Thomas, Jerilyn Christensen, Stephanie A. Owens, Stacy Deputy County Recorder Correctional Officer Correctional Officer

A motion to approve the recommended appointments was made by Councilman Gibbons. It was seconded and carried unanimously. (Vice Chairman Anhder absent)

#### VICE CHAIRMAN C. LARRY ANHDER ARRIVES

Vice Chairman Anhder arrived at the meeting at 5;15 p.m.

#### REPORT OF THE COUNTY EXECUTIVE CONTINUED

- 2. Legislative meeting: Lemon reported that members of the State Legislature, Hyrum City and E. A. Millers had met to discuss changes in the Utah Code dealing with annexation requirement. It was determined that an agreement would be drafted between Hyrum City, E. A. Millers and the County. The agreement would allow Millers to continue construction on their expansion project if Hyrum City and E. A. Miller sign an agreement. The agreement would satisfy the delivery of services from Hyrum City. The City would draft an ordinance regulating the amount of odor allowable. Lemon recommended that the Council support the proposed agreement. Councilman Gibbons suggested that a time frame be set and that no construction begin until the agreement is signed.
- 3. Bear Lake Dredging: Lemon and Chairman Skanchy attended a meeting between the Friends of Bear Lake, Irrigation Companies and water users. The Friends of Bear Lake are protesting a proposed dredging project on the North end of the lake that would allow the delivery of additional water from the lake, down river. The Friends are suggesting that they would not oppose the dredging if a model is made that would show where other river waters come from and that water users would conserve and manage the water properly.

A motion to support the proposed recommendation and to send a letter to the State of Idaho & the Corps of Engineers. The motion was made by Councilman Gibbons it was properly seconded and carried unanimously.

4. Property Tax Settlement: Kristie Jorgensen a Hyrum resident has requested that because of hardships her penalty and interest on her past taxes be eliminated. Her taxes would be \$1491.00 and the penalty and interest is \$375.0 over a three year period.

A motion to approve the request was made by Councilman Gibbons It was properly seconded and carried unanimously.

- 5. Public Employee Insurance: Executive Lemon told the Council that the 1995 budget contains a 8% increase in the employee insurance program. However, the insurance company has notified him that there will not be any increase this year.
- 6. County Finance Report: The County Auditor, Tamra Stones and County Treasurer, Karen A. Jeppesen appeared before the County Council to give a finance report for 1994. Stones said that the report shows a healthy fund balance and the county is in good financial condition. She discussed the departments balance sheets and fund summaries. Treasurer Jeppesen, reported that the 1994 tax collection rate was 98.41 even after a tax increase. The collection rate was the best in six years. She thanked the people of the county and said that we have great people living here.
- 7. Targeted Fund Allocation Application: An application from Logan City applying for funding to study future landfill sites and other concerns with solid waste. Lemon recommends that the application be placed as the second priority.
  - A motion to approve the application as second priority was made by Vice Chairman Anhder. It was properly seconded and carried unanimously.
  - 8. Warrant Register: The County Warrant Register for the month of February was presented. The Register is on file in the County Clerk's Office.

#### TRANSPORTATION ENHANCEMENT APPLICATION: KEITH SHAW

Keith Shaw, from the First District Juvenile Court appeared before the Council to ask for their support as they apply for an ISTEA grant. The grant would fund a project to plant wild flowers along portions of the highways in the County.

Nick Galloway representing the Benson Culinary Water District is requesting that the Council set a public hearing. A motion to close the public hearing was made by Councilman Gibbons. It was seconded and carried unanimously.

A motion to approve the changes in the 1995 budget was made by Councilman Gibbons. It was properly seconded and carried unanimously.

#### RESOLUTION NO. 95-04: 1995 BUDGET ADJUSTMENTS

A motion to adopt Resolution No. 95-04 was made by Councilman Gibbons. It was seconded and carried unanimously.

# THE COUNCIL ADJOURNED FROM THE REGULAR COUNCIL MEETING INTO A BOARD OF EQUALIZATION

The Board discussed and acted on three property tax exemption applications.

1. Somebody's Attic: Some question concerning the charitable requirements to allow a tax exemption was discussed. Auditor Stones said that the application meets all necessary requirements to qualify for exemption.

A motion to approve the application was made by Councilman Gibbons. It was seconded and passed on a 6 "Yes" to 1 "No" vote. Vice Chairman Anhder voted "No".

- 2. Child and Family Support Center: Stones said that this application meets all necessary requirements.
- A motion to approve the application was made by Councilman Allen. It was seconded and carried unanimously.
- 3. Seventh-Day Adventists: They are applying for exemption for religious requirements.

A motion to approve the application was made by Vice Chairman Anhder. It was seconded and carried unanimously.

#### THE BOARD ADJOURNED BACK INTO THE REGULAR COUNCIL MEETING

#### SURPLUS REAL PROPERTY: 300 SOUTH 600 WEST NEWTON-PUBLIC HEARING SET

The County acquired a 1/4 ac. parcel of property at the May tax sale in 1942. The property has bee farmed by a family in Newton since then. The family wants to purchase the property. Lemon suggested that the parcel be declared surplus and sold and entered back on the property tax roll.

A motion to set the necessary public hearing on March 14, at 6:00 p.m. was made by Councilman Allen. It was properly seconded and carried unanimously.

#### PUBLIC HEARING: SURPLUS REAL PROPERTY: OLD 600 SOUTH

Chairman Skanchy convened a public hearing at 6:15 p.m.. To discuss and to receive public input on a proposed exchange of a small parcel of property owned by the county for another parcel of property owned by Utah Power & Light Company. Executive Lemon, recommended the exchange. UP & L wants to legalize ownership of the property and make an exchange.

Chairman Skanchy asked for comment from the audience. No public input was made.

A motion to close the public hearing was made by Councilman Pulsipher. It was seconded and carried unanimously.

A motion to approve Executive Lemons recommendation to declare

the property surplus was made by Councilman Gibbons.

#### RESOLUTION NO. 95-05: SURPLUS REAL PROPERTY

A motion to adopt Resolution No 95-05 was made by Councilman Gibbons. It was properly seconded and carried unanimously.

# RESOLUTION: NO. 95-06-COUNTYWIDE LIBRARY SYSTEM CREATION-FIRST READING

The newly created Library Foundation Chairman, Miles Jensen presented for first reading a resolution that if adopted will assist the foundation in raising funds for a Countywide Library System. Some Council members were concerned about the funding process. The resolution will be discussed at the next Council meeting.

Councilman Petersen, asked the Chairman for a point of special privilege? To allow comment from a member of the audience. The request was granted. Valerie Elder, a concerned mother from Hyde Park, expressed the importance of a Library to her family and how she can't get any library service. She wants a Countywide Library system.

#### SPECIAL PERMIT REQUEST: WESTON SIGN

Chairman Skanchy, began the discussion of the Weston's special permit request. By reviewing the past history and actions concerning the Weston sign issue. She said that Council members have been deluged with letters from concerned citizens wanting something done with the sign. A letter from the County Attorney was mentioned. Skanchy said that we are trying to solve the problem legally. Skanchy updated the Council as to the past action on special use permit decisions that the Council have made. A map showing the FR 40 zoning area in the county was reviewed. Skanchy said that other areas such as Beaver Mountain ski area and Franklin Basin have been mentioned as possible development areas. The Weston family has submitted some proposed changes in the sign.

Councilman Allen questioned the Lundahl sign near Beaver Mountain. Lorene Greenhalgh said that the new sign hasn't been constructed yet.

Councilman Gibbons suggested that we are talking about two different areas and Logan Canyon is not the same as Wellsville

Canyon. He said that the Weston sign should be modified. The height should remain the same for visibility but the read out portion of the sign is not necessary. Gibbons said, that any fine should include Westons expense to cover the sign. He is recommending that the sign stay where it is with modification.

Councilman Beck said that the fine should be enough so that it would discourage others, from doing what has been done by the Westons. He believes that any fines should come from the County administration and not the legislative body.

Council Petersen said that he believes that there are other optional signs that could be constructed, that are not as damaging to the environment. He said that he can't vote for the sign that is there now.

Councilman Gibbons, said that 80% of those who have contacted him have expressed, that the private property rights of the Westons should be addressed. He said that the present ordinance is pretty stingy when it comes to property rights. Gibbons stated that the Westons have invested a lot of money in their development of the area and we should help them. He believes that the area would become an asset to the community.

Councilman Beck said that the Westons have a right to make the business succeed.

Councilman Gibbons moved that the County Executive be charged with setting the amount of the fine. To let the sign remain without the reader board portion. It was seconded by Councilman Pulsipher.

Gibbons said that the sign post is not out of place anymore than the highway itself.

Councilman Petersen presented an amendment to the motion that would lower the sign to 35 feet. The amendment passed on 4"Yes" to 3 "No" vote. Councilman Beck, Pulsipher and Gibbons voted "No".

Chairman Skanchy said that she does not like the advertising sign and she recommends an identity sign to let people know what is there. She said that the present sign should be taken down. Also that the process to construct the sign should start over. The Westons should obtain a building permit that would allow the necessary inspections to take place. Councilman Gibbons said that he would add the building permit requirement to his motion.

The County Attorney Scott Wyatt told the Council that any fine would have to be set by a judge. He recommends that a settlement

between the County and the Westons be made tonight.

Councilman Petersen said that a revision of the ordinance should be made.

Councilman Gibbons amended his original motion not to include a fine set by the County Executive.

Chairman Skanchy said that she thinks that as a penalty, the sign should be taken down, remove the reader board, shorten the sign to 35 feet and obtain a building permit to reconstruct the sign.

Councilman Gibbons made a substitute motion. The motion is to have, as the penalty, the Westons take the sign down, remove the reader board, cut the height of the sign down to 35 feet. Before reconstruction begins they must obtain a building permit and allow proper inspections. After construction the ground under the sign is to be landscaped to blend in with the area. The motion was seconded and passed on a 5 "Yes" to 2 "No" vote.

#### COUNCILMEN LAYNE M. BECK AND DARREL L. GIBBONS LEAVE THE MEETING

Councilmen Beck and Gibbons left the meeting at 7:35 p.m.

# RESOLUTION NO. 95-07: GRANTING EASEMENT TO SMITHFIELD IRRIGATION COMPANY

The President of the Smithfield Irrigation Company Jeff Gittins asked the Council to adopt Resolution No. 95-07. The Resolution establishes the county right-of-way and gives easement to Smithfield Irrigation Co. which will allow a ditch to run along the side of the county road.

A motion to waive the rules of first & second reading and adopt Resolution No. 95-07 was made by Vice Chairman Anhder. It was seconded and carried unanimously. Councilmen Beck & Gibbons absent)

#### CULINARY WATER APPROPRIATIONS: DISCUSSION

Executive Lemon said that some problems are occurring with those wanting to build a home and who want to also drill wells. Some are building first, without having water. Also the state gives a well drilling permit which qualifies for a building permit.

Jeff Gittins, said that people are also drilling wells and not building home. Then they use the water for irrigation which is illegal.

#### LEGISLATIVE UPDATE

Executive Lemon updated the Council on some legislation being addressed at the state. Road funding, Targeted Allocation and Annexation bills were discussed.

Point of personal privilege was granted to Vice Chairman Anhder to recognize Nibley City Mayor Jay Nelson and his wife. The mayor inquired about a well permit granted to the county some time ago in his area.

#### LETTER TO STATE ENGINEER: THAD ERICKSON

The County Water Coordinator Thad Erickson has drafted a letter to the State Engineer concerning water management in the county.

Erickson wants the County Executive to sign the letter and forward it to the State Engineer.

It was the consensus of the Council to have the letter signed and sent by the County Executive.

#### COUNCIL MEMBER REPORTS

Councilman Petersen: Suggested that the sign ordinance be looked at as soon as possible. It was suggested that the Countywide Planner become involved.

Councilman Pulsipher: Recommends that the Countywide Planner make a presentation to the Council at the first meeting in April.

#### FEDERAL FUNDING CUTS: EXTENSION SERVICE

It was reported that the Federal Government is recommending cutting funding for Extension Service. Chairman Skanchy will write a letter to our congressmen encouraging them to vote against the recommendation.

#### ADJOURNMENT

No further business was brought before the Council and Chairman Skanchy adjourned the meeting at  $8:00\ p.m.$

Your suggestion for a water management plan for Cache County has received the support of our Water Policy Advisory Board. We are working toward defining better just what this means by doing a study that will support formulation of this water development plan. We are looking for alternatives and funding.

We understand you will be giving a presentation on ground water management plans at the Utah Water Users Workshop in March, and that you plan to hold a public meeting in Cache County in April. A good plan will include coordination of all levels of government.

Cache County is developing a comprehensive plan to guide the growth we are experiencing. Logan City representation on our Water Policy Advisory Board has stated that they would rather not wait for the comprehensive plan, but prefer to move more quickly on water planning to guide decisions they must soon make.
